Be it duly noted these minutes of Oct. 21, 2019 are UNOFFICIAL minutes.

The Board of Supervisors met in regular session at 8:30 a.m., with Board members Corey Eberling-Chairman, and Gary McVicker present; Mike Nolte absent

Chairman Eberling led the Pledge of Allegiance.

Motion by McVicker, seconded by Eberling, approves the Agenda as submitted with the addition of: 1) Amendment to Resolution 2019-54. All ayes. Motion carried.

Motion by McVicker, seconded by Eberling, approves the Minutes of Oct. 14, 2019. All ayes. Motion carried.

Committee Updates: FCDA; Workforce Development

Supervisor Nolte arrived at 8:40 a.m. Landfill Post-Closure finalization in FY2020 was discussed.

Dan Tilkes, Sanitarian and Weed Commissioner, presented the Weed Commissioner Report for 2019.

Motion by McVicker, seconded by Nolte, approves the 2019 Franklin County Weed Commissioner Report as presented. All ayes, motion carried.

Darwin Meyer and Myron VanHorn, representing the Franklin County Historical Society, met to request deed to the historical building property located at the Franklin County Fairground. The Board stated once the abstract to the property has been completed, then it would be beneficial for the Fair Board, Historical Society Commission and the Supervisors to meet and determine a resolution to the said requests. No action taken.

Motion by McVicker, seconded by Nolte, approves amendment to Resolution 2019-54 changing the wage of the Auditor's office Drainage Clerk position due to an error. Said Resolution reads as follows:

APPOINTMENT OF A DRAINAGE CLERK IN THE FRANKLIN COUNTY AUDITOR'S OFFICE

WHEREAS, the Franklin County Auditor, has hired KELLY REED to the part-time position of Drainage Clerk effective on the 12th day of September, 2019.

WHEREAS, being this position is rated as non-exempt, the hourly rate is set at \$16 per hour and after a six month probationary period increase the hourly rate to \$16.70 per hour; being retroactive to the starting date of Sept. 12, 2019.

ADOPTED this 21st day of October, 2019 with the vote thereon being as follows:

Eberling-Aye, McVicker-Aye, Nolte-Absent. Amended Resolution duly adopted. Rural Recycling Program in Franklin County was discussed.

Motion by McVicker, seconded by Nolte, directs the County Attorney to write a letter of discontinuation for rural recycling services in Franklin County and terminating the contract with Waste Management Systems, as of Dec. 31, 2019; due to continued abuse of garbage being dumped in the recycling bins causing contamination. All ayes, motion carried.

Motion by Nolte, seconded by McVicker, approves claims for period ending Oct. 20, 2019. All ayes, motion carried.

At 11 a.m. the Board discussed some 2020 Legislative Priorities.

Motion by Nolte, seconded by McVicker, adjourns at 12:02 p.m., until Oct. 28, 2019. All ayes. Motion carried.
